- Rastriya Banijya Bank Ltd (RBBL) invites electronic bids from eligible bidders for the procurement of <u>The Supply & Delivery of 120 nos. Laptop</u> under National Competitive Bidding Single Stage Two Envelope procedures as specified in Public procurement acts & regulations.
- 2. Laptops have been classified in three different Packages (Pkg A-25 nos., Pkg B-40 nos. & Pkg C-55 Nos.) and eligible bidders may bid for single package or more than one package. Details of Laptop (Technical Specification) for each Pkg have been annexed in bid document.
- 3. **Under the Single Stage, Two Envelope Procedure**, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the **Technical Bid** and the other (ii) the **Price Bid**, both in turn enclosed in one sealed envelope as per the provision of ITB 23 of the Bidding Document
- 4. Bidder must submit their bid electronically only before **Falgun 06, 2080 (Feb 18, 2024) 12:00 Noon** Bidder can download the bidding documents for e-submission from PPMO's e-GP system *www.bolpatra.gov.np/egp*. To submit bid electronically, bidder should deposit the cost of bidding document in the following account as specified below.

- 5. The electronic bids will be opened in the presence of Bidders' representatives who choose to attend at Falgun 06, 2080 (Feb 18, 2024) 12:30 P.M. at the office of RBBL, General Service Department, Central Office, Singhadurbarplaza.
- 6. Bids must be valid for a period of **90 Days** from the date of bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a *minimum of NRs* **80,000.00** for pkg A, *NRs* **1,00,000.00** for pkg B and *NRs* **1,40,000.00** for pkg C, which shall be *valid for minimum 30 days* beyond the bid validity period. If the bidder wants to bid for more than one package then the bid security shall be the combination of mentioned bid security amount of each pkgs.
- 7. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
- 8. The purchaser reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
